New initiative from three renown NGOs: International Climate Solidarity Levies

Three renown non-governmental organizations, ICCCAD, the Innovative Finance Foundation, and Oxford Climate Policy, have joined forces to propose the use of "International Climate Solidarity Levies". Their initiative demonstrates how levies can be developed to mobilize funding for the new Loss & Damage Response Fund.

With climate change causing loss and damage to societies around the world, the Loss and Damage Response Fund established last year at the UN climate summit, COP27, intends to address the plight of the most vulnerable.

Given the urgency to provide financial support to the poorest and most vulnerable countries to respond to climate induced loss and damage and given the current global economic and fiscal situation, it is difficult to see how the new fund could get adequately capitalized without diverting funds from other existing multilateral climate funds.

A levy could for example be added to airline tickets, as already being applied in France. Such an air levy in EU could mobilize 1 bn Euro, which could help people and communities facing droughts, floods, and cyclones in some of the most vulnerable countries.

Governments are currently discussing how the COP27 decision should be implemented, and how the new loss and damage response fund should be capitalized. The International Climate Solidary Levies initiative is a direct answer to this question.
